Emergency Procedures

Collect the material and place into a suitable labelled container. Do not dilute material but contain. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

Precautions for Safe Handling

Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use.
